For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned agrees, represents and warrants to Chandler Vaqueros Saddle Club (CVSC), their directors, officers, members, agents and assigns as follows: I am representing to you that I am an experienced horse rider and fully aware of the risks and dangers involved in horseback riding. I do understand that even under the best of circumstances a rider can be hurt through no negligence of anyone other than himself. It is my responsibility to inspect all equipment used and the horse I am to ride. Thereafter, I take full responsibility for any injury that I may incur by reason of my riding, racing, or other activity at any time or during any event with the CVSC.

I have had this document fully explained to me. I fully understand and agree with all its items and conditions. Therefore, based upon my experience and representations made in the Agreement, I hereby agree to release the CVSC, Horseshoe Park And Equestrian Center, The Town of Queen Creek, and Pinal County, County, their directors, officers, members, agents and assigns from any and all legal claims including personal injury or property damage which might arise as a result of any occurrence or happening arising out of my riding or racing on my horse or any other horse provided to me. I agree not to bring or prosecute any litigation against any of you for such injury that may arise on or after the date of execution of this Agreement. This agreement shall further apply to any and all CVSC events and this Agreement may not be modified or waived without prior written consent of a duly authorized agent of the CVSC.

I agree to indemnify and hold the CVSC, Horseshoe Park And Equestrian Center, The Town of Queen Creek, and Pinal County, County, their directors, officers, members, agents and assigns harmless from any and all claims, actions, losses, damages, costs and expenses arising out of, resulting from or in connection with any act or conduct of the undersigned, family members and children of the undersigned, or my guests, their family members and their children.

In participating, I am permitting the CVSC to use the rider's picture, name, voice, and words on television, radio, film, newspaper, magazine, Internet and other media and in any form, for the purpose of advertising, sponsorship or communicating the purposes of the CVSC and/or applying for funds to support those purposes and activities.

If a provision of the Agreement is determined to be invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall not be affected or impaired in any way.

## **2018-2019 CVSC Warm-up Arena Safety**

As with any sport there is “etiquette”. During all CVSC events, we have the warm-up arena for your use which accommodates several riders. Warm-ups should only take place in the assigned warm-up arena. Safety involves your surroundings. Be aware of any tools, vehicles, or ground equipment in the area at all times. The following are guidelines to increase the safety of our riders and their horses while in the warm- up arena. Please read and sign the bottom of this form indicating that you have read these “Warm-up Arena Etiquette and Safety Rules”.

### Disruptive actions and words can spook horses and cause riders to be injured!

- When possible, mount and dismount your horse outside of the Warm-up arena. If you are warming up for an event that requires dismounting, please be aware of the riders around you.
- Be courteous when entering the arena. Move in the direction of the majority of other riders when first entering the arena, instead of interrupting the flow.
- If passing someone going the opposite direction, use the left shoulder to left shoulder rule. This means always moving to your right ,just like when driving a car.
- Do not tail gate other horses! Leave at least one horse lengths between you and the horse ahead of you.
- Leave the outside for faster horses with the slower riders on the inside. For example, if the majority of horses are walking, but you need to trot, then move to the outside.
- Be courteous, positive and polite when riding with others. Cue your horses quietly and remember basic warm-up manners such as no smoking, no swearing, and no phone use in the arena.
- There is absolutely no “hotlapping” in the arena.
- There is absolutely no lunging your horse in the warm-up arena.
- If someone is not following warm-up arena rules or is engaging in disruptive behavior, please advise a Board Member immediately.
- Be prepared for equine emergencies at all times! Warm-up emergencies can be anything from a rider stopping too quickly, a bucking horse, or someone falling off of their mount.
