# **HPEC Reopening Guidelines**



Facility

- Post signs with CDC guidelines that acknowledge compliance is the personal responsibility of the individual
  - The CDC recommends the following to help prevent the spread of COVID-19:
    - Stay home if you are sick
    - Avoid gatherings of 10 or more people
    - Maintain at least 6 feet from others
    - Wash your hands frequently with soap and water for at least 20 seconds
    - Cover your cough/sneeze
    - Complying with these guidelines and taking precautions to protect yourself and others against the spread of COVID-19 is the personal responsibility of individuals.

- Daily cleaning/disinfecting all bathroom surfaces
- Spray mix of Synbiont (animal safe anti-pathogen) and Bleach on high-touch areas daily
- Stalls: Barn alleys are 12' wide and stall openings are 10 12 feet apart
  - Staff cleaning stalls will wear disposable masks and spray each stall with Synbiont between each use (Current normal guidelines)
- CDC guidelines for Outdoor areas:
  - Outdoor areas generally require normal routine cleaning, but do not require disinfection
  - High touch surfaces made of plastic or metal, such as grab bars and railing should be cleaned routinely
  - Cleaning and disinfection of wooden surfaces or groundcovers (mulch, sand) is not recommended
  - Sidewalks and road should not be disinfected.

# HPEC Staff

- Maintain social distancing and wear masks when interacting with customers.
- Office Staff (hand sanitizer is currently installed just inside office door)
  - Reservations made/paid for by phone, limited in person payments by appointment with appropriate social distancing; Event close meetings can be held in HPEC office with appropriate social distancing
  - o Office staff will wear masks when interacting with customers and other staff members

# Concessions

- Place markings on concrete spaced 6' apart to assist with social distancing
- Space picnic tables farther apart to meet social distancing guidelines
- Concessions staff will wipe tables with bleach solution between uses
- Hand sanitizer has already been installed at the order window

# Event Staff

- Producer will provide HPEC a plan of how they will implement and enforce current CDC guidelines.
- Producer will obtain COVID-19 Liability Release Waivers from participants and staff and retain a list of participants for 30 days following the event.
- Minimize lines and encourage appropriate social distancing
- Show Office (hand sanitizer already installed inside show office)
  - 6 people maximum in show office at a time (including show staff), show staff sanitize high touch areas throughout the day
  - Masks required to be worn in the show office

# Participants

• Encourage appropriate social distancing and following CDC guidelines (see signage above, enforcement handled by show staff)

# Spectators

- Facility staff will block off sections of seating to encourage social distancing
- Encourage appropriate social distancing and following CDC guidelines (see signage above, enforcement handled by show staff)

# Vendors

- Space vendors a minimum of 12 feet apart
- Limit gatherings at vendors to a maximum of 2 guests/customers in a vendor booth at a time
- Follow current CDC guidelines for masks/social distancing.
